OFFICIAL RULES
NO PURCHASE NECESSARY TO ENTER OR WIN.

1. DESCRIPTION: THIS SWEEPSTAKES (“SWEEPSTAKES”) IS NOT OPEN TO THE GENERAL PUBLIC. YOU MUST BE A CURRENT BENJAMIN MOORE PROFESSIONAL PAINTERS ADVISORY BOARD MEMBER AND COMPLETE AT LEAST ONE ONLINE SURVEY DURING THE SWEEPSTAKES PERIOD. NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. YOU HAVE NOT YET WON. The Benjamin Moore Professional Painters Advisory Board Sweepstakes 2 (“**Sweepstakes**”) starts at 12:00:01 A.M. Pacific time on July 1, 2011 and ends at 11:59:59 P.M. Pacific time on December 31, 2011 (“**Sweepstakes Period**”). The administrator of this Sweepstakes is COHEN-FRIEDBERG ASSOCIATES, LLC, Framingham, MA 01702 (“**Administrator**”). The sponsor of this Sweepstakes is MarketTools, Inc., 150 Spear Street, Suite 600, San Francisco, CA 94105 USA (“**Sponsor**”).

2. HOW TO ENTER There are two ways to enter **1)** Benjamin Moore Professional Painters advisory Board survey members will be sent an invitation via email to participate in a survey. Panel members who complete the survey will receive one entry into the Sweepstakes. **2)** A free alternate means of entry (“**AMOE**”): Legibly hand print on a postcard your complete name, street address (no P.O. Boxes, please), city, state, zip code, country, daytime telephone number, age, and email address, and mail it to: Benjamin Moore Professional Painters Advisory Board Sweepstakes 2, P.O. Box 2242, Framingham, MA 01703-2242 USA. You must first be a Benjamin Moore Professional Painters advisory Board Member before you submit a mail in form of entry. Limit of one AMOE per person. AMOEs received outside of the Sweepstakes Period will not be eligible for the Sweepstakes drawing. Sponsor and Administrator not responsible for auto generated, lost, late, mutilated, or postage-due AMOEs. Panel Members must be residents of the United States who are at least 18 years old at the time of entry, and who complete the Survey, will be automatically entered into the Sweepstakes. Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. All Sweepstakes entries and materials submitted become the property of the Sponsor and shall not be acknowledged or returned. Sweepstakes entrants must provide all information requested to be eligible to win. Incomplete, unreadable, or unintelligible entries shall be disqualified. Entries generated by a script, macro or other automated means shall be disqualified.

Sweepstakes is open only to Benjamin Moore Professional Painters Advisory Board Members who are invited to take an Online Survey, are residents of the United States or Canada (excluding the province of Quebec) who are at least 18 years old at the time of entry, and who complete the Online Survey. There may be multiple survey invitations sent during the sweepstakes period. Each survey completed will earn an entry into the sweepstakes. Any individuals (including but not limited to employees, consultants, independent contractors and interns) who have, within six months prior to the Start Date, held employment with or performed services for Sponsor, Administrator (collectively, “**Sweepstakes Entities**”) or any organizations affiliated with the sponsorship, fulfillment, administration, prize support, advertisement or promotion of the Sweepstakes, are not eligible to enter or win.
