

**Responsibility Project Sweepstakes  
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

**1. DESCRIPTION: THIS SWEEPSTAKES (“SWEEPSTAKES”) IS OPEN TO THE GENERAL PUBLIC. YOU MUST COMPLETE THE ONLINE SURVEY DURING THE SWEEPSTAKES PERIOD. NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. YOU HAVE NOT YET WON.** The Responsibility Project Sweepstakes (“Sweepstakes”) starts at 12:00:01 A.M. Pacific Time (“PT”) on Wednesday, August 1, 2012 and ends at 11:59:59 P.M. PT on Wednesday, October 31, 2012 (“Sweepstakes Period”). The administrator of this Sweepstakes is COHEN-FRIEDBERG ASSOCIATES, LLC, Framingham, MA 01702 (“Administrator”). The sponsor of this Sweepstakes is MarketTools, Inc., 150 Spear Street, Suite 600, San Francisco, CA 94105 USA (“Sponsor”).

**2. HOW TO ENTER** There are two ways to enter **1)** Random survey invitations will "Pop-Up" on the Responsibility.com website during the Sweepstakes Period. The invitation will request users to participate in the survey. Participants must complete the survey to receive one entry into the Sweepstakes. **2)** A free alternate means of entry (“AMOE”): Legibly hand print on a postcard your complete name, street address (no P.O. Boxes, please), city, state, zip code, daytime telephone number, age, and email address, and mail it to: August Responsibility Project , P.O. Box 2242, Framingham, MA 01703-2242 USA. Limit of one AMOE per person. AMOEs received outside of the Sweepstakes Period will not be eligible for the Sweepstakes drawing. Sponsor and Administrator not responsible for auto generated, lost, late, mutilated, or postage-due AMOEs. Online participants must be residents of the United States who are at least 18 years old at the time of entry, and who complete the Survey in order to be automatically entered into the Sweepstakes. Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. All Sweepstakes entries and materials submitted become the property of the Sponsor and shall not be acknowledged or returned. Sweepstakes entrants must provide all information requested to be eligible to win. Incomplete, unreadable, or unintelligible entries shall be disqualified. Entries generated by a script, macro or other automated means shall be disqualified.

**3. ELIGIBILITY: This Sweepstakes is open to the general public.** Sweepstakes is open only those who receive a "Pop-UP" invitation while visiting the Responsibility.com website, participate by completing the Online Survey, are residents of the United States who are at least 18 years old at the time of entry.
